DEAFvibe Friend : Junior <i>(under 18 years old)</i>	<ul style="list-style-type: none"> • Must be accompanied by an adult, family or legal guardian, who have agreed to be responsible for them; • Have no voting rights and cannot participate the AGM or other special meetings; • Subject to the Child Protection Act at all times.
Executive Trustee	<ul style="list-style-type: none"> • Must be appointed by the Board of Trustees as a fellow Trustee; • Has full voting powers at AGM and other special meetings; • Must demonstrate proof of expertise, experience and commitment to the satisfaction of the Board.
Corporate Supporter <i>(a company, business or other organisation)</i>	<ul style="list-style-type: none"> • Show they support DEAFvibe Charity by act or deed; • No voting rights; • May send representative(s) to open meetings; • Show a willingness to join in and support our activities and events.
